



**AUTOZONE ACCELERATE YOUR REPAIRS GIVEAWAY
OFFICIAL RULES**

1. ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN. Purchasing a product or service will not increase your chances of winning. Open to legal US Residents of the 48 contiguous United States, the District of Columbia or Puerto Rico who are at least 18 years of age or older as of the date of entry (the "Entrant"). The Entrant who is selected as the potential grand prize winner (the "Grand Prize Winner") must report income to the Internal Revenue Service ("IRS") and will be required to complete, sign and return and IRS form W-9. In the event it is deemed during the verification process that such potential Grand Prize Winner does not have a unique, personal and valid social security number for Sponsor (or any party acting on its behalf) to report the tax liability associated with acceptance of the respective prize, such potential Grand Prize Winner will be disqualified. Valid social security numbers will be determined by IRS requirements. Employees, officers and directors of AutoZone Parts, Inc. and its subsidiaries and affiliates (the "Sponsor"), its distributors, vendors, advertising/promotion agencies, and any others engaged in the development, production, execution or distribution of this Sweepstakes, including, but not limited to, the entities supplying the Prizes herein as well as their immediate family members (spouses, siblings, children and parents, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible to participate. All federal, state and local laws and regulations apply. Sweepstakes is void in US territories and possessions located outside of the United States and where ever else prohibited or restricted by law.

TO ENTER: The AutoZone Accelerate Your Repairs Giveaway (the "Sweepstakes") begins at 12:00 a.m. Central Time (CT) on July 4, 2010 and ends at 11:59 p.m. CT on October 4, 2010 (the "Sweepstakes Period"). For purposes of these Official Rules, all times are given in Central Time. There are two (2) ways to enter:

Enter via Qualifying Online Purchase: Visit www.autozone.com (the "Website") between 12:00 a.m. CT on July 4, 2010 and 11:59 p.m. CT on October 4, 2010 and make a "Qualifying Online Purchase". A "Qualifying Online Purchase" is defined as the online purchase of a sales floor or hard part in which "Store Pick Up" is selected during check out; meaning that the Entrant will pick up his/her purchase in person at a local AutoZone retail store located in the forty eight (48) contiguous United States, the District of Columbia or Puerto Rico. Entrants will earn one (1) entry for every Qualifying Online Purchase made during the Sweepstakes Period. **A limit of one hundred (100) entries may be obtained per Entrant during the Sweepstakes Period via Qualifying Online Purchase.** Any attempt to make Qualifying Online Purchases and return products for the purposes of obtaining entries into the Sweepstakes will void that Entrant's entries and that Entrant may be disqualified from the Sweepstakes. Entries are subject to order number validation and verification.

Enter By Mail: To enter without making a Qualifying Online Purchase, Entrants may enter by mail as follows: On a plain 3" x 5" card, legibly handprint or type your first name, last name, complete residential address, city, state, zip code, telephone number (including area code), date of birth and email address (if available) to: "AutoZone Accelerate Your Repairs Giveaway, 90 Rockwood Place, Rochester, New York 14610. Mail entries must be postmarked by October 4, 2010 and received by October 11, 2010 to be eligible for the Sweepstakes. **A limit of one hundred (100) entries may be obtained per Entrant during the Sweepstakes Period by mail.** The first forty five (45) envelopes submitted by a single Entrant shall each be considered two (2) entries into Sweepstakes. The forty sixth (46th) envelope submitted by such Entrant shall be considered ten (10) entries into the Sweepstakes. Entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Neither the Sponsor, nor The National Sweepstakes Company (the "Independent Administrator") will verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage due mailed entries.

Regardless of the method in which you choose to enter, either via a Qualifying Online Purchase or by mail without a purchase, there is a limit of (100) entries per person during the Sweepstakes Period. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, telephone numbers, identities, and/or any other methods will void that Entrant's plays and that Entrant may be disqualified from the Sweepstakes.

WINNING/ODDS: On or about October 25, 2010, one (1) Grand Prize Winner will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period by the Independent Administrator, whose decisions are based on its sole discretion and interpretation of these official rules, and are final and binding in all respects. Odds of being selected as the Grand Prize Winner will depend upon the total number of eligible entries received during the Sweepstakes Period. Potential Grand Prize Winner will be notified by telephone, mail or email. Further details for claiming the Grand Prize is outlined under the "Prize Claims" Section of these official rules.
