

AUTOZONE GARAGE MAKEOVER CONTEST
OFFICIAL RULES

1. **ELIGIBILITY:** Open to AutoZone Rewards Members who are a legal US Resident of one of the forty-eight (48) contiguous United States, the District of Columbia or Puerto Rico and at least eighteen (18) years of age or older as of the date of entry (the "Entrant"). Employees, officers and directors of BP Lubricants USA Inc. and AutoZone Parts, Inc. together with their distributors, vendors, advertising/promotion agencies, and any others engaged in the development, production, execution or distribution of this Contest, including, but not limited to, the entities supplying the Prizes herein (collectively, the "Contest Entities") as well as their immediate family members (spouses, siblings, children and parents, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible to participate. 3. **TO ENTER:** All Entrants must be an AutoZone Rewards Member (the "Member") to be eligible to enter the Contest. Any Entrant, who is not an existing Member, must first become a Member for free by enrolling at any AutoZone retail location in the forty-eight (48) contiguous United States, the District of Columbia or Puerto Rico. To enter the Contest, make a purchase of 5 quarts or more of Castrol EDGE® or EDGE® High Mileage, register for the Contest at the Contest site <https://apfco.com/secured/S8186W> and provide proof of purchase, upload a photo of your garage with Castrol product, and tell us in 100 words or less how Castrol and AutoZone can help you with a Garage Makeover.

JUDGING: Entries will be judged according to the following criteria, up to 25 points will be awarded for originality, up to 25 points for appropriateness to theme, up to 25 points for functionality (can we achieve your vision for a garage makeover) and up to 25 points for clarity of expression, for a total of 100 possible points. The highest individual point total will be declared the Grand Prize Winner. The judging will be conducted by an Independent Administrator, who will employ qualified judges in the automotive and design fields, and whose decisions are final and binding in all aspects.
