

## 2024 AUTOZONE RTR VEHICLES SWEEPSTAKES

### OFFICIAL RULES

**1. a. **Eligibility:** This Sweepstakes is open to legal United States residents residing in the fifty (50) United States, the District of Columbia and Puerto Rico who are 18 years of age or older.
